OSTİM TECHNICAL UNIVERSITY INTERNATIONAL STUDENT ADMISSION DIRECTIVE

SECTION ONE Initial Provisions

Aim

ARTICLE 1 - (1) The aim of this Directive is to determine the principles and procedures for the admission of international students to Associate, Undergraduate and Graduate programs within OSTİM Technical University.

Scope

ARTICLE 2 - (1) This Directive regulates the quota, tuition fee, application, admission, evaluation and registration criteria for the admission of international students to Associate, Undergraduate and Graduate programmes at OSTİM Technical University.

Basis

ARTICLE 3 - (1) Prepared on the basis of ARTICLE 45/f of the Higher Education Law No. 2547, <u>the Principles and Decisions of the Council of Higher Education on the Admission</u> of Students from Abroad.

Definitions and Abbreviations

ARTICLE 4 - (1) The definitions and abbreviations in this Regulation shall be defined as follows:

a) ROT: Republic of Türkiye,

b) TRNC: Turkish Republic of Northern Cyprus,

c) MEB: Ministry of National Education,

d) YÖK: Council of Higher Education,

e) ÖSYM: Measuring, Selection and Placement Center,

f) University: OSTİM Technical University,

g) Board of Trustees: OSTIM Technical University Board of Trustees,

h) Rector: Rector of OSTIM Technical University,

i) Senate: Senate of OSTIM Technical University,

j) Faculty: Faculties of OSTIM Technical University,

k) MYO: the Vocational School of OSTIM Technical University,

l) SFL: School of Foreign Languages,

m) DİLMER: Language Teaching Application and Research Center

n) Graduate School: Graduate Schools of OSTİM Technical University,

o) Director of Graduate School: the relevant Graduate School's Director within OSTİM Technical University,

p) Board of Graduate School: Board of Directors of the relevant Graduate School of OSTİM Technical University,

r) Heads of Departments: Heads of the programs of the Graduate School of OSTİM Technical University,

s) International Students: Foreign national students who are graduates of high school, undergraduate, or graduate programs, students with dual nationality (who have acquired Turkish citizenship later and have proved this with an extract of civil registration), or Turkish students who have completed their entire high school education abroad, are individuals who are granted the right to study at a university in Türkiye, utilizing the special quotas allocated for them under specific conditions.

t) Foreign National Student: A foreign national student who does not hold Turkish nationality and is subject to legislation regarding residence permits, work permits and private health insurance.

SECTION TWO

General Principles for International Students Admission

Quotas

ARTICLE 5 - (1) International student quotas are determined through the approval of the Board of Higher Education following the proposals of Faculties and Graduate Schools and the decision of the University Senate and Board of Trustees.

(2) The University has the discretion to fill or not fill its international student quotas. Quota transfers between departments/ programs may be made in cases where deemed necessary, provided that they are carried out in accordance with the legislation.

Tuition Fees

ARTICLE 6 - (1) International student tuition fees are determined by the Board of Trustees every year upon the proposal of the Board of Directors.

English/Turkish language proficiency exam types and minimum scores

ARTICLE 7 - (1) **English language proficiency requirement:**

a) International students whose applications to Associate, Bachelor's, or Graduate programs where the medium of instruction is English have been approved and who have enrolled will be required to take the OSTİM Technical University English Proficiency Exam on the dates specified in the academic calendar.

b) Enrolled students begin their educations as English Preparatory students until they take the next proficiency exam specified in the academic calendar. Student attendance is mandatory from the date of their enrollment at the University.

c) Students who get a 60 or above from the OSTİM Technical University English Proficiency Exam are exempt from English Preparatory School classes and may start their programs immediately.

d) Students who fail the English Proficiency Exam by scoring 59 or below will continue their studies in the University's English Preparatory Program for one year. At the end of the year, students who succeed will begin the first year of their enrolled programs. Those who fail will be granted an additional year. If they are still unsuccessful at the end of this year, their affiliation with the University will be terminated. The conditions for successfully completing the English Preparatory Program are subject to the provisions of the OSTİM Technical University English Preparatory School Regulations.

e) Students who provide proof of obtaining at least 60 points in the Foreign Language Proficiency Exam (YDS) conducted by ÖSYM, or students who present a certificate of results from other exams deemed equivalent to YDS according to the ÖSYM Foreign Language Exam Equivalence Table (such as CPE, CAE, TOEFL iBT, PTE Academic), with the minimum scores specified in the table below, will be exempt from the preparatory class and may directly begin the first year of their respective programs. TOEFL Home Edition is not valid for exemption from the English Preparatory Program are specified in the table below.

f) Except for the exams administered by ÖSYM (YDS/e-YDS), the results of other external exams (such as CPE, CAE, TOEFL iBT, PTE Academic) to be used for exemption must be submitted to the University (School of Foreign Languages) in a sealed and stamped envelope or submitted by authorized exam centers to the <u>io@ostimteknik.edu.tr</u> and <u>infoyabanci@ostimteknik.edu.tr</u> email addresses.

g) Applicants whose native language is the language of instruction for the program, or those who have completed undergraduate and/or graduate studies in a country where the program language is the official language, as well as applicants who have graduated from OSTIM Technical University's English Bachelor's programs within the last two years, are not required to submit an English Proficiency Exam result or an English Language Proficiency Certificate when applying to programs where English is the medium of instruction. The English language proficiency of these students may be determined through an interview and, if necessary, a written exam conducted by the School of Foreign Languages and Graduate School.

(2) Turkish language proficiency requirement:

a) International students whose applications have been approved and enrolled in Associate, Bachelor's, or Graduate programs with Turkish as the medium of instruction will be required to take the OSTİM Technical University Turkish Language Proficiency Test (OSTİMTECH TLPT) on the dates specified in the academic calendar.

b) Enrolled students begin their educations as Turkish Preparatory Students until they take the next proficiency exam specified in the academic calendar. Student attendance is mandatory from the date of their enrollment at the University.

c) Students who get a 60 or above from OSTİMTECH TLPT are exempt from Preparatory School Classes and may start their programs immediately.

d) Students with insufficient Turkish language proficiency or those who score below 60 on the OSTİMTECH TLPT will be enrolled in the Turkish Preparatory Class for a one-year period at the University's DİLMER. Students who do not take the OSTİMTECH TLPT will begin their Turkish Preparatory program at the A1 level. At the end of the year, students who succeed will begin the first year of their enrolled program. Those who fail will be given an additional year. If they are still unsuccessful at the end of this year, their affiliation with the University will be terminated. The conditions for successfully completing the Turkish Preparatory Program are subject to the provisions of the OSTİM Technical University Language Teaching, Application and Research Center Regulations.

e) International students who present valid European Language Portfolio (ELP) certificate with a level equivalent to B2 or higher, obtained from <u>Institutions whose Proficiency</u> <u>Certificates are Recognized</u> by the Yunus Emre Institute and the OSTİM Technical University Senate based on reciprocity may be exempt from the Turkish Preparatory Program upon submitting a petition for exemption. These students may directly begin the first year of their respective programs. The current list of institutions approved for Turkish Proficiency Certificates can be accessed on the OSTİM Technical University DİLMER website (<u>https://www.ostimteknik.edu.tr/dilmer-5799/3749</u>).

f) The following students will not be required to present any proficiency certificate for Turkish language, and their Turkish proficiency level will be considered sufficient for them to begin their enrolled programs. These students will be exempt from the Turkish Preparatory Program upon submitting a request for exemption and will directly start their program.

- Students who have completed their secondary education in Turkish high schools within Türkiye under the Ministry of National Education.

- Students who have completed their secondary education in Turkish schools established abroad under the Ministry of National Education.

- Students who have completed their secondary education in the Ministry of National Education's Open Education High School Overseas Programs.

- Blue Card holders.

- Students with dual nationality, whose primary or initial nationality is Turkish, but who have also acquired citizenship from another country.

- Students specified under the 'Students Not Required to Apply for Equivalency' clause in the Ministry of National Education's Equivalence Regulation.

g) Applicants who have successfully completed their undergraduate and/or graduate studies in a country where Turkish is the official language, as well as candidates who have

graduated from OSTİM Technical University's Turkish Bachelor's programs within the last two years, are not required to submit a Turkish Proficiency Exam/Turkish Language Proficiency Certificate when applying to Graduate programs where Turkish as the medium of instruction. The Turkish language proficiency of these students may be determined through an interview and, if necessary, a written exam conducted by DİLMER and the Graduate School.

Health Insurance

ARTICLE 8 – (1) **General Health Insurance (GSS):** International students can become covered by General Health Insurance by applying in writing to the Social Security Institution within three months from the date of their initial registration, in accordance with ARTICLE 60 of the Social Insurance and General Health Insurance Law No. 5510. Students who do not make this application within the specified period will not be subject to general health insurance provisions during their studies. Those who have their general health insurance registrations made by the Social Security Institution are responsible for paying the health insurance premium, which is 4% of the minimum wage.

(2) **Private Health Insurance:** Foreign national students who will obtain a residence permit under the Residence Law are required to have **Private Health Insurance**. The annual health insurance must be included among the documents required for the residence application. Private Health Insurance for foreign national students is reported to insurance agencies by the Ministry. If the conditions are met, the policy is approved by the Directorate of Migration Management. It is required that the policy includes coverage for both inpatient and outpatient treatments, as well as private health insurance and residence permit. The coverage of Private Health Insurance is only valid for emergency situations at contracted private hospitals. This insurance will cover funeral expenses in the event of the foreign student's death within the territory of the Republic of Türkiye. This type of health insurance is not valid in State Hospitals.

(3) The application of Private Health Insurance for foreign national students is valid until the regulation on the mandatory General Health Insurance comes into effect.

SECTION THREE

Principles for International Student Admission to Associate and Undergraduate Programs

Associate and Undergraduate Application Requirements

ARTICLE 9 - (1) Applications will be accepted for the programs announced by the University as open to international students, provided the applicants are either in their final year of high school or have already graduated, and those who meet the following conditions shall be admitted:

a) Foreign national students, (provided that those who have studied at secondary education (high school) institutions in Türkiye were registered before the 2022-2023 academic year (excluding students from embassy schools, international private educational institutions listed in the MOBIS system, and foreign national students brought to our country under projects conducted by the Ministry of National Education),

b) Those who were born as Turkish citizens and lost their Turkish citizenship by obtaining permission from the Ministry of the Interior to renounce their citizenship, as well as those who have lost their Turkish citizenship and have proof of holding a blue card (provided that those who have studied at secondary education (high school) institutions in Türkiye were registered before the 2022-2023 academic year) (it is advisable for candidates applying for quotas from abroad to review the Turkish Citizenship Law, as ARTICLE 7 of Law No. 5901 states: '(1) A child born to a Turkish mother or through a Turkish father within the unity of marriage either in Türkiye or abroad is a Turkish citizen.',

c) Those who were foreign nationals but later acquired Turkish citizenship, that is dual citizens in this situation (provided that those who have studied at secondary education (high school) institutions in Türkiye were registered before the 2022-2023 academic year),

d) Turkish citizens who have completed their entire secondary education (high school) in a foreign country, except in the TRNC (including those who completed their entire secondary education (high school) in Turkish schools established by the Ministry of National Education in foreign countries outside the TRNC)

e) TRNC nationals who reside in the TRNC and have completed their secondary education (high school) there with GCE AL exam results, as well as those who enrolled in colleges and high schools in other countries between 2005 and 2010 and have or will have GCE AL exam results, or TRNC citizens who have completed their entire secondary education (high school) in a foreign country and have TR-YÖS results,

Applicants must also meet one of the criteria listed in the 'OSTİM Technical University Associate and Undergraduate International Student Admission High School Diploma and Exam Criteria' provided in Annex-1.

(2) However, the applications of the following applicants will be rejected:

a) Citizens of the Republic of Türkiye who have completed their entire secondary education (high school) in Türkiye or the TRNC,

b) TRNC nationals (excluding those who have completed their secondary education (high school) in TRNC schools and hold GCE AL exam results, as well as those who attended colleges and high schools in other countries between 2005 and 2010 and obtained or will obtain GCE AL exam results, or those who completed their secondary education abroad and hold the TR-YÖS result),

c) Dual nationals with Turkish citizenship as their first nationality, as defined in paragraph (1)(b) in this section, except those who meet the conditions specified in paragraph (1)(d),

d) Dual nationals with one nationality being TRNC (excluding those who have completed their secondary education (high school) in TRNC schools and hold GCE AL exam results, as well as those who attended colleges and high schools in other countries between 2005 and 2010 and obtained or will obtain GCE AL exam results, or those who completed their secondary education abroad and hold the TR-YÖS result),

e) Turkish citizens or dual citizens whose first nationality at birth is Turkish as defined in paragraph (1)(b) in this section who have studied at schools within the embassies in Türkiye or in foreign high schools in Türkiye,

f) TRNC citizens and those who have renounced their Turkish citizenship or hold a Blue Card, as well as foreign nationals who will enroll in secondary education institutions in Türkiye starting from the 2022-2023 academic year (except foreign national students who are enrolled in embassy schools, international private educational institutions listed in the MOBIS system, and those brought to our country under projects conducted by the Ministry of National Education),

g) (Amendment-1, Ex officio, in accordance with the letter from the Higher Education Council (YÖK) Department of Education, dated 03.12.2024, Number: E-75850160-010.04-74457, regarding the 'Principles for the Admission of International Students) In consideration of the following points regarding TRNC citizens, as well as those who have lost Turkish citizenship or hold a Blue Card, and foreign nationals who have studied or graduated from secondary education institutions in Türkiye until 2026, these applicants may,

- Apply for quotas allocated for the admission of international students and enrolling in higher education institutions.

- Enroll in higher education institutions through both international student quotas and the Higher Education Examination (YKS) for TRNC citizens and those who have renounced Turkish citizenship/Blue Card holders.

- Ensure that candidates face no disadvantages and utilizing the application rights for international student quotas until 2026.

Having regard to the fact that, as of 2026, candidates will only be placed in higher education institutions based on their YKS results, the following applications shall not be accepted:

(i) Applications from candidates who have enrolled in Türkiye's secondary education institutions starting from the 2022-2023 academic year and will graduate or have already graduated from secondary education, and

(ii) Applications from candidates who enrolled in Türkiye's secondary education institutions before the 2022-2023 academic year and/or have graduated, as it has been deemed appropriate for these candidates to be placed in higher education institutions in our country and in the TRNC solely through YKS as of 2026 (excluding embassy schools, international private educational institutions listed in the MOBIS system, and foreign nationals brought to our country as part of projects conducted by the Ministry of National Education).

Application procedures and required documents for Associate and Bachelor's Degree programs

ARTICLE 10 - (1) Applications must be submitted within the application dates announced in the academic calendar by completing the online application form available on the University's website and uploading the required documents listed below to the online system completely and accurately.

(2) The documents required for the application are as follows:

a) Online Application Form

b) Passport (the pages of the passport showing the holder's identification details and validity period, along with their Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille),

c) High School Diploma (a Turkish translation of the diploma or the education status certificate issued by relevant school for students who are at the graduation stage at the time of application, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille)

d) High School Transcript (an official transcript issued and approved by the high school administration, showing the courses taken and grades achieved by the prospective student in high school, along with its Turkish translation which must be notarized, certified by Turkish diplomatic missions, or accompanied by an apostille),

e) High School Graduation Certificate or University Entrance Exam Result Document (if applicable, a notarized Turkish translation, or a Turkish translation certified by Turkish foreign representative offices, or a Turkish translation with an apostille of the exam result document specified in Annex-1 of the OSTİM Technical University Associate and Undergraduate International Student Admission High School Diploma and Examination Criteria),

f) One biometric photograph.

Evaluation of Applications for Associate and Undergraduate Programs

ARTICLE 11 – (1) The evaluation and admission of international students who have applied are carried out by the Associate and Undergraduate International Student Evaluation Committee, which is established by the Senate, within the period specified in the academic calendar.

(2) The University has the discretion to fill or not fill the quotas. Meeting the application requirements does not guarantee placement for a program.

(3) Applications from candidates who do not meet the Associate and Undergraduate Application Requirements will not be evaluated.

(4) Applications from candidates who meet the Associate and Undergraduate Application Requirements, upload their application documents completely and accurately to the online application portal, and satisfy the criteria outlined in the 'OSTİM Technical University Associate and Undergraduate International Student Admission High School Diploma and Examination Criteria' provided in the Annex-1 will be accepted.

(5) An official acceptance letter is issued by OSTİM Technical University to candidates whose applications are accepted, enabling them to obtain a visa from the Republic of Türkiye's foreign representative offices (Embassy or Consulate).

Registration and required documents for associate and undergraduate programs

ARTICLE 12 - (1) Registrations are carried out within the dates announced in the calendar determined by the YÖK (Council of Higher Education).

(2) The documents required for the final registration of the student to the University are as follows:

a) Passport (the pages of the passport showing the holder's identification details and validity period, along with their Turkish translation, which must be notarized, certified by Turkish diplomatic missions, or accompanied by an apostille),

b) A photocopy of the passport page showing the border entry stamp,

c) A photocopy of the visa sticker/page in the passport (except for those exempt from a visa),

d) High School Diploma (the original copy of diploma, or for newly graduated students whose diploma has not yet been issued at the time of registration, the official provisional certificate of graduation, along with their Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille).

e) High School Transcript (An official transcript issued and approved by the high school administration, showing the courses taken and grades achieved by the prospective student in high school, along with their Turkish translation, which must be notarized, certified by Turkish diplomatic missions, or accompanied by an apostille),

f) High School Graduation Certificate or University Entrance Exam Result Document (If applicable, for candidates with an exam result document specified in the 'OSTİM Technical University Associate and Undergraduate International Student Admission High School Diploma and Examination Criteria' provided in the Annex, a notarized copy of the exam result document, along with its Turkish translation certified by Turkish diplomatic missions, or accompanied by an apostille),

g) English/ Turkish Language Exam Result Document (If applicable, a notarized copy of the internationally recognized Foreign Language Certificate or Turkish Proficiency Certificate specified in Article 7, along with its Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille),

h) Tuition Fee Bank Receipt (Bank receipt showing the payment of the tuition fee),

i) If applicable; Stateless Person Identification Document, International Protection/Status Identity Document, Temporary Protection Identity Document, or Foreign Representative Staff/Family Member Identity Card,

j) Four biometric photographs (4.5 x 6.0 cm in size, recent and reflecting the current appearance),

k) Private Health Insurance (valid for at least 1 year),

1) Disability Report (if applicable, the report of the disability status),

m) Blue Card (if the student has renounced Turkish citizenship and acquired citizenship from another country, a photocopy of the 'Blue Card'),

n) Equivalence Certificate (only for students who are citizens of the Republic of Türkiye and have completed their entire high school education abroad, excluding those who graduated from high schools abroad affiliated with the Ministry of National Education),

o) Dates of Entry and Exit to/from Türkiye (only for students who are citizens of the Republic of Türkiye and have completed their entire high school education abroad, excluding those who graduated from high schools abroad affiliated with the Ministry of National Education; the entry and exit records must be obtained via the e-Government portal),

p) Extract of Civil Registration (obtained from the e-Government portal; required for dual-national international students who later acquired Turkish citizenship),

r) Other forms to be filled out during registration,

(3) The international student is required to submit their Residence Permit, which they will obtain from the Provincial Directorate of Migration Management to the University within three months following the enrollment date.

(4) The University will review the documents pertaining to the entry and residency of international students coming to Türkiye for higher education purposes during the registration process. The University will not process the enrollment of foreign nationals without a legal right to reside in Türkiye.

(5) The University will not refer foreign students coming to Türkiye for higher education to Turkish language courses/ centers before completing their student enrollment.

SECTION FOUR

Principles for the Admission of International Students to Graduate Programs Application requirements for graduate programs

ARTICLE 13 – (1) To be eligible to apply for a Master's program, applicants must hold an Bachelor's degree from a university.

(2) To be eligible to apply for a Doctoral program, applicants must have completed a Master's degree with a thesis from a university.

Application procedure and required documents for Master's and Doctoral programs

ARTICLE 14 - (1) Applications must be submitted within the application dates announced in the academic calendar by completing the online application form available on the University's website and uploading the required documents listed below to the online system completely and accurately.

(2) The documents required for the application are as follows:

a) Online Application Form,

b) Passport (the pages of the passport showing the holder's identification details and validity period, along with their Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille),

c) Bachelor's Degree Diploma (for applications to master's programs; a copy of the bachelor's degree diploma and transcript, prepared in English or Turkish, certified by the Ministry of Education or foreign representative offices of the relevant countries),

d) Master's Degree Diploma (for applications to doctoral programs; copies of both the bachelor's and master's degree diplomas and transcripts, prepared in English or Turkish, certified by the Ministry of Education or foreign representative offices of the relevant countries),

e) Bachelor's Transcript (for registration in master's programs; an official transcript showing the courses taken and grades achieved at the university, along with its Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille),

f) Master's Transcript (for registration in doctoral programs; an official transcript showing the courses taken and grades achieved in the master's program, along with its Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille),

g) Letter of Recommendation (upon request by the relevant Graduate School Directorates),

h) Letter of Intent (upon request by the relevant Graduate School Directorates),

i) Disability Report (if applicable, the report of the disability status),

j) Blue Card (if the student has renounced Turkish citizenship and acquired citizenship from another country, a photocopy of the 'Blue Card'),

k) The Minimum Required Scores for Language Proficiency Exams Specified in Article 7,

l) A biometric photograph must be uploaded to the online application form.

Evaluation of Applications for Graduate Programs

ARTICLE 15 – (1) Evaluation of applications Master's programs

a) The evaluation of international students' applications for the master's program is conducted based on the submitted/ received application documents.

b) The 'School Recognition' status of the university from which the candidate graduated is checked first.

c) Applications of applicants whose 'School Recognition' is approved are subject to preliminary review by the Directors of Graduate School Departments. During the preliminary review, the applicant's bachelor's degree qualification and transcript of records are evaluated to determine whether the candidate is suitable for the program and whether there is a need for conversion courses. If deemed necessary by the Departments' Directors, an online interview may be conducted prior to acceptance.

d) The evaluation and admission of international applicants are carried out by the International Student Evaluation Committee for Graduate Programs, established by the Senate within the period specified in the academic calendar.

e) The University has the discretion to fill or not fill the quotas. Meeting the application requirements does not guarantee placement for a program.

f) An official acceptance letter is issued by OSTİM Technical University to candidates whose applications are accepted, enabling them to obtain a visa from the Republic of Türkiye's foreign representative offices (Embassy or Consulate).

(2) Evaluation of applications to PhD programs

a) The evaluation of international students' applications for the doctoral programs is conducted based on the submitted/ received application documents.

b) The 'School Recognition' status of the university from which the applicant graduated is checked first.

c) Applications of applicants whose 'School Recognition' is approved are subject to preliminary review by the Directors of Graduate School Departments. During the preliminary review, the applicant's master's degree qualification and transcript of records are evaluated to determine whether the candidate is suitable for the program and whether there is a need for conversion courses. If deemed necessary by the Departments' Directors, an online interview may be conducted prior to acceptance.

d) The evaluation and admission of international applicants are carried out by the International Student Evaluation Committee for Graduate Programs, established by the Senate within the period specified in the academic calendar.

e) The University has the discretion to fill or not fill the quotas. Meeting the application requirements does not guarantee placement for a program.

f) An official acceptance letter is issued by OSTİM Technical University to candidates whose applications are accepted, enabling them to obtain a visa from the Republic of Türkiye's foreign representative offices (Embassy or Consulate).

Registration and Required Documents for Graduate Programs

ARTICLE 16 – (1) Admission letters will be sent to students who have been granted final registration rights. Students who receive an admission letter must, personally, submit the required documents listed below to the relevant Graduate School Secretariat during the registration period specified in the academic calendar to complete their enrollment.

Documents Required for the Final Registration:

a) Passport (a notarized copy of the pages of the passport showing the holder's identification details and validity period, as well as a notarized copy of its Turkish translation),

b) A photocopy of the passport page showing the border entry stamp,

c) A photocopy of the visa sticker/page in the passport (except for those exempt from a visa),

d) University Diploma (for registration in Master's programs, the original copy of University diploma, or for newly graduated students whose diploma has not yet been issued at

the time of registration, the official provisional certificate of graduation, along with their Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille).

e) Master's Diploma (for registration in Doctoral programs, the original Master's diploma, or for newly graduated students whose diploma has not yet been issued at the time of registration, the official provisional certificate of graduation, along with their Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille)

f) Bachelor's Transcript (for registration in master's programs; an official transcript showing the courses taken and grades achieved at the university, along with its Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille),

g) Master's Transcript (for registration in doctoral programs; an official transcript showing the courses taken and grades achieved in the master's program, along with its Turkish translation, which must be notarized or certified by Turkish diplomatic missions, or accompanied by an apostille),

h) English/ Turkish Language Exam Result Document (If applicable, a notarized copy of the internationally recognized Foreign Language Certificate or Turkish Proficiency Certificate specified in Article 7, along with its Turkish translation certified by Turkish diplomatic missions, or accompanied by an apostille),

i) Tuition Fee Bank Receipt (Bank receipt showing the payment of the tuition fee),

j) If applicable; Stateless Person Identification Document, International Protection/Status Identity Document, Temporary Protection Identity Document, or Foreign Representative Staff/Family Member Identity Card,

k) Visa (visa issued by Turkish diplomatic missions)

l) Four biometric photographs (4.5 x 6.0 cm in size, recent and reflecting the current appearance),

m) Private Health Insurance (valid for at least 1 year),

n) Disability Report (if applicable, the report of the disability status),

o) Extract of Civil Registration (obtained from the e-Government portal; required for dual-national international students who later acquired Turkish citizenship),

p) School Recognition (obtained from e-Government. For international applicants who are unable to access the e-Government services, the school recognition will be provided by the International Relations Office staff of OSTİM Technical University.)

r) Other forms to be filled out during registration,

(3) The international student is required to submit their Residence Permit, which they will obtain from the Provincial Directorate of Migration Management to the University within three months following the enrollment date.

(4) The University will review the documents pertaining to the entry and residency of international students coming to Türkiye for higher education purposes during the registration process. The University will not process the enrollment of foreign nationals without a legal right to reside in Türkiye.

(5) The University will not refer foreign students coming to Türkiye for higher education to Turkish language courses/ centers before completing their student enrollment.

SECTION FIVE

Miscellaneous and Final Provisions

The provisions subjected to Accepted International Students

ARTICLE 17 - (1) International students admitted to the University are subject to:

a) The provisions of the Higher Education Law No. 2547 and other relevant legislations,

- b) Decisions of the Higher Education Council,
- c) University Legislations and Decisions,

d) OSTİM Technical University Associate and Undergraduate Education and Examination Regulation,

e) OSTİM Technical University Graduate Education and Training Regulation and other regulatory provisions.

(2) Students are required to inform the University of any personal, civil, residence, passport, and all other changes.

(3) Foreign nationals coming to Türkiye for educational purposes are required to comply with the provisions of the Passport Law No. 5682, other relevant laws of the Republic of Türkiye, as well as the regulations and principles underlying this Directive and other related legal provisions. The University shall not be held responsible for any loss of rights incurred due to their failure to fulfill these obligations.

Those who make false statements

ARTICLE 18 - (1) Applications of applicants who are found to have forged documents, provided false information, or who have misled the University through any action or procedure, will be rejected.

(2) If the registration of these prospective students have already been processed, the student's registration will be canceled, their affiliation with the University will be terminated, and the Council of Higher Education (YÖK) will be notified.

Conditions without Provisions

ARTICLE 19 - (1) In the cases where there are no provisions in this Directive, the following Regulations and decisions shall apply.

a) OSTİM Technical University Associate and Undergraduate Education and Examination Regulation,

b) OSTİM Technical University Graduate Education and Training Regulation,

c) OSTİM Technical University Senate decisions,

d) OSTİM Technical University legislation,

e) The Higher Education Council's Graduate Education and Training Regulation,

f) The relevant other decisions of the Higher Education Council.

Regulatory Authority

ARTICLE 20 – (1) Any amendments made by the Higher Education Council (YÖK) regarding the Principles for the Admission of Students from Abroad will be automatically incorporated into this Directive.

Repealed Directive

ARTICLE 21 – (1) With the enactment of this Directive, the OSTİM Technical University Directive on the Admission of International Students, regulated by the University Senate's Decision No. 114 dated 26.09.2023, shall be repealed.

Enforcement

ARTICLE 22 -(1) This Directive shall enter into force on the date it is approved by the Board of Trustees.

Execution

ARTICLE 23 – (1) This Directive shall be executed by the Rector of OSTİM Technical University.
